
#### **VZM Services**



the organization with managers and employees from within the organization. Often elements of these plans are simultaneously implemented with the support of the VZM team.


Typical areas of team focus are short term cost reductions, turn-time or dispatch reliability improvements, smarter sales and more effective performance management.

In a constantly changing business environment new opportunities will always emerge.




